

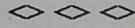

Reference to your application to Railway Recruitment Board/Secunderabad, you are offered, an appointment to the post of Trainee CMA in Level-6/ GP ₹4200/- in the Chemical & Metallurgical Organization of Mechanical Department on South Central Railway on Stipend of Rs.35,400/- per month plus dearness allowance as admissible under the rules in force from time-to-time subject to on production of your original certificate and satisfactory proof in support of your age such as S.S.L.C/Matriculation/S.S.C/H.S.C. Certificate etc.,

- 2) You should execute an agreement bond to serve as Trainee for twelve months in the form prescribed by the Administration [copy enclosed]. This Agreement must be attested by your parent or guardian and One Surety preferably a Railway Employee whose Grade Pay is equal/higher with that of the Post selected. The certificate regarding Pay and Salary of the Surety is to be signed by his Pay Drawing Officer. The special adhesive stamp of the value about ₹10/- to be affixed on the Agreement should also be borne by you.
- 3) You will be under training normally for a period of twelve months and if there is any adverse report during the period of Training, your Training will be liable to be terminated. Your absorption as Trainee CMA will be subject to your successfully completing the training.
- 4) No guarantee or promise of employment will be given but on the satisfactory completion of your training period, you will be eligible for appointment as CMA in Level-6/ GP ₹4200/- if there is a vacancy. In case of retention in services, you will be placed on probation and will be required to enter into a fresh agreement in the form of agreement in force for Group 'C' staff on this Railway. Appointment will be subject to all the rules and regulations issued by the Government of India and South Central Railway Administration from time-to-time.

fail to serve the Administration for a minimum period of five years as stated above or desire to withdraw from Training for any reasons which are not beyond your control or try to withdraw by willfully absenting yourself or adopting any other unfair tactics, you will be liable to refund the whole cost of your training as well as any other money paid to you during the period of training by way of stipend/pay etc., In addition, the cost of training will be 12 ½% of pay and allowance drawn/paid.

6) You will not be entitled to any notice of termination of service or pay in lieu thereof if such termination is due to expiry of the sanction of the post which you hold or to your removal or dismissal as a disciplinary measure after compliance with provisions of Clause [2] of Article 311 of the Constitution of India, otherwise your service will be liable for termination on 14 days notice on either side.

7) You will not be eligible for any Pension or any benefit under the State Railway Provident Fund or Gratuity Rules or to any allowance beyond those admissible to temporary employees under the rules in force from time-to-time during such temporary service.

8) You will come under the purview of the new restructured defined Contribution Pension System introduced w.e.f. 01.01.2004 vide Railway Board's letter No. F(E)III/2003/PN1/24, dated 31.12.2003 [CPO/SC's Serial Circular No.10/2004] but not under the Pension Scheme existing upto 31.12.2003.
